„Alexhost” SRL, as the provider, hereinafter referred to as the "**Operator**", represented by **Scutaru Alexandru, the Director**, and \_\_\_\_\_ represented by \_\_\_\_\_, **the Director**, hereinafter referred to as the "**Subscriber**", have mutually agreed to state the services to be provided by the **provider** and the price to be paid for these services by the **beneficiary** as follows:

**Art. 1.3.1. Services and tariffs**

\*\*Prices expressed in EURO shall be calculated in MDL at the exchange rate of the NBM on the day of invoice/payment.

**Art. 1.3.2. Payments frequency:**  **monthly** /  **annual (tick).**

**Art. 1.3.3. Rules and conditions of payment**

- The monthly payment for the Dedicated Server is made by the Subscriber as an advance in the amount of 100% of the total price.
- The monthly payment for the Dedicated Server is deducted from the account of the Subscriber, in the total amount, after offering the technical access to the Dedicated Server or prolonging the right to use the Dedicated Server for the next period of use, from the date of invoice, regardless the amount the Subscriber has on his account.
- The monthly payment for the Dedicated Server can not be refunded – it represents the expenses of the Operator for the technical maintenance of the Dedicated Server.
- The Subscriber is entitled to use uninterrupted the Dedicated Server during the paid period.

**Art. 1.3.4. IP Addresses**

The tariff plan price includes one IP address. The price for other additional IP addresses (IPV4) is included in an additional tariff plan as follows:

Quantity: 1-10 IP addresses	25 lei / 1ip
Quantity: 10-50 IP addresses	22 lei / 1ip
Quantity: 50-100 IP addresses	20 lei / 1ip
Quantity: 100-200 IP addresses	17 lei / 1ip
Quantity: 200-300 IP addresses	12 lei / 1ip
Quantity: 300-500 IP addresses	10 lei / 1ip
Quantity: 500-1000 IP addresses	8 lei / 1ip
* Other tariff plan can be discussed in separately	

**Art. 1.3.5. Additional restrictions to the use of the Dedicated Server and rights of the Operator**

- It is strictly prohibited to use the Dedicated Server for providing wholesale services (such as, public e-mail services, redirection services, etc.).
- In case of failure to comply with the abovementioned restrictions, the Operator undertakes the right to suspend the Dedicated Server services, without prior notice of the Subscriber.
- If the Subscriber violates regularly the restrictions (2-3 times) and takes no steps to improve the situation, the Operator undertakes the right to lock the Subscriber' Dedicated Server, without prior notice.
- If the Subscriber violates the restrictions and the rules, the Operator is entitled, with or without prior notice, to cease providing the services to the Subscriber and/or to delete all the Subscriber's resources.
- The Operator has the right to modify independently the restrictions and the rules in order to improve the operation of the system in whole and to improve the quality of the offered services.
- The Operator's inaction in case of violation by the Subscriber of the restrictions imposed by the tariff plans, does not deprive the Operator from undertaking the necessary measures to protect its rights, as well as, is not a waiver of its rights in case of committing a similar or alike violation.
- The disconnection of the Dedicated Server (at the request of the Subscriber, as well as at the initiative of the Operator) is considered a maintenance service, and not a refusal/suspension of the services, that is why the monthly payment remains unchanged.
